THAT the Advisory Planning Committee recommends that Council support Development Variance Permit Application DVP00671 to vary Zoning Bylaw 6000, Table 7.7 - Parking, Loading, and Bike Parking, Vehicle Parking Spaces, increasing the total vehicle parking spaces from 222 to 371 for a commercial development on Lot A, Sec. 26, TP 9, ODYD, Plan EPP141756 (1501 Highway 6), as outlined in the report titled "Development Variance Permit for 1501 Highway 6", dated January 22, 2025.
