Re: Advocating for Inclusion of BC Craft Spirits in Government Liquor Stores and Revising  
Production Caps for BC Craft Distilleries

---

On behalf of City of Vernon Council, I am writing to provide our support of the Greater Vernon Chamber of Commerce's letter to you dated February 10, 2025, advocating for policies that support the inclusion of BC craft spirits in government liquor stores and the elimination or increase of the current production cap for BC Craft Distilleries.

Current provincial regulations limit full craft designation benefits to distilleries producing up to 50,000 litres of spirits annually, with reduced support up to 100,000 litres. These limits financially penalize distilleries that exceed the threshold, discouraging growth and expansion in a sector vital to local economies, tourism, agriculture, and innovation.

We believe these restrictions are outdated, especially given recent retaliatory tariffs and the removal of U.S. liquor products from publicly owned stores. These actions highlight the need to support domestic producers and improve access to local, BC-made spirits.

We advocate for reevaluating the cap and related policies to foster responsible growth and business development. A flexible, updated framework would better support the Province's objectives for economic development, food and beverage innovation, and rural resilience.

The City of Vernon urges the Province to:

1. Review and raise, or eliminate the 50,000-litre cap on annual production for full craft designation;
2. Implement a non-punitive, graduated scale that promotes sustainable business growth; and
3. Align BC's regulatory framework with its economic development and Buy Local priorities.

City of Vernon Council is committed to advocating for a business environment that empowers local entrepreneurs, supports regional economies, and reflects the changing needs and opportunities within British Columbia's communities.

Attached is the letter from the Greater Vernon Chamber of Commerce dated February 10, 2025, advocating for BC Craft Distilleries.

Dear Premier Eby and MLA Sandhu,

On behalf of the Greater Vernon Chamber of Commerce, I write to express our appreciation for the government's recent initiative to promote Canadian-made spirits by temporarily removing certain U.S. products from BC Liquor Store shelves. This action has provided a noticeable boost to local distilleries as consumers have increasingly turned to homegrown alternatives.

This situation has highlighted longstanding challenges that British Columbia's craft distilleries face in accessing government-controlled retail channels. Despite the quality and uniqueness of their products many local distilleries find it difficult to secure shelf space in BC Liquor Stores. This limited access hinders their growth and restricts consumer choice.

A significant barrier to this issue is the production cap currently imposed on craft distilleries. According to existing regulations, distilleries must produce no more than 50,000 liters of spirits per year and use 100% British Columbia agricultural inputs to qualify for the "craft" designation and receive full markup relief. Surpassing the threshold subjects producers to substantial markups thereby making expansion financially prohibitive.

While this production limit was initially established to support small-scale operations it now serves as a constraint for many distilleries trying to meet growing consumer demand. The cap discourages scalability and innovation, as distilleries are reluctant to expand production due to financial penalties associated with exceeding the limit.

In light of these challenges and in consideration of the recent positive response to local spirits, we urge the provincial government to consider the following actions:

1. **Facilitate Greater Access to BC Liquor Stores:** Implement policies that prioritize and promote the inclusion of British Columbia craft spirits in government liquor stores, thereby supporting local businesses and offering consumers a wider selection of homegrown products.
2. **Reevaluate the Production Cap:** Increase or eliminate the current 50,000-litre annual production cap to allow craft distilleries to scale their operations in response to market demand without facing prohibitive financial penalties.


