SUBJECT:

2023 GRANT REQUEST FROM O'KEEFE RANCH

Attached to this memo is a request from the O'Keefe Ranch & Interior Heritage Society for an operating grant of \$150,000 for 2023. The City annually includes in the Financial Plan a base grant of \$50,000 funded from taxation. For 2022, the total operating grant was \$125,000 with the additional \$75,000 approved by Council to be funded from the Casino Grant Reserve. The estimated 2022 year-end balance in the Reserve is \$592,000 based on budgeted incoming Casino funds of \$1.5 million in 2022. The actual first and second quarterly payments total \$870,000. There is a realistic possibility that the year-end balance for 2022 could be \$100,000 to \$200,000 more than originally expected.

## RECOMMENDATION:

THAT Council receive for information the memorandum titled "2023 Grant Request from O'Keefe Ranch" dated September 13, 2022 and respectfully submitted by the Manager, Financial Planning & Reporting;

AND FURTHER, that Council direct Administration to include in the 2023 Financial Plan, as a Service Level Adjustment, an operating grant of \$150,000 for O'Keefe Ranch & Interior Heritage Society to be funded \$50,000 from taxation and \$100,000 from the Casino Grant Reserve as outlined in the memorandum titled '2023 Grant Request from O'Keefe Ranch' dated September 13, 2022 and respectfully submitted by the Manager, Financial Planning & Reporting;

AND FURTHER, that the Service Level Adjustment be included in the 2023 proposed budget for Council's consideration.
