In 2022, the City was advised that members of the North Okanagan Canada Society would not be continuing the organization of Canada Day celebrations due to a lack of volunteers. The City passed the following resolution (declassified on April 25, 2022):

'THAT Council direct Administration, on behalf of the North Okanagan Canada Day Society, to reach out to the community to seek energetic volunteers to participate in the Canada Day Committee to plan and implement Canada Day celebrations in 2022 and 2023;

AND FURTHER, that those interested community members be invited to attend a meeting at City Hall on May 11, 2022.'

The North Okanagan Canada Day Society has a new president, Mayla Janzen. Ms. Janzen is requesting a Council representative be appointed in preparation for 2023 Canada Day celebrations (Attachment 1). The previous appointed Council representative was Scott Anderson.
